 <p>Richard Green Professor of Sustainable Energy Business, Imperial College London</p>	<p><b>‘The Impact of Wind Power on Electricity Markets’</b></p> <p>Professor Green has been studying the economics and regulation of the electricity industry for over 20 years. He has written extensively on market power in wholesale electricity markets and has also worked on transmission pricing. More recently, the main focus of his work has been on the impact of low-carbon generation (nuclear and renewables) on the electricity market, and the business and policy implications of this.</p>
 <p>Terry Barker Chairman of Cambridge Econometrics and Senior Department Fellow, 4CMR, Department of Land Economy University of Cambridge</p>	<p><b>‘The costs of stringent climate policy: what are the costs? and were the IPCC AR4 estimates biased in being too low?’</b></p> <p>Professor Barker is an economist with over 140 papers and books published mainly on economic modelling, energy economics, climate change mitigation policies and international trade. He was a Co-ordinating Lead Author for the IPCC’s Third and Fourth Assessment Reports 2001 and 2007, taking responsibility for chapters on cross-sectoral greenhouse gas mitigation. His research interests are in “New Economics” and in developing and using large-scale models designed to address the issue of global decarbonisation at the UK, European and global scales.</p>
 <p>Scott Barrett Professor of Natural Resource Economics, Columbia University</p>	<p><b>‘Collective Action to Avoid Climate Catastrophe’</b></p> <p>Professor Barrett is a leading scholar on transnational and global challenges, ranging from climate change to disease eradication. His research focuses on how institutions like norms, customary law, resolutions, and treaties can be used to promote international cooperation. Barrett's research has been awarded the Resources for the Future Dissertation Prize and the Erik Kempe Award.</p>
